Subject: Annual Election of The Members of Executive Committee for the year 2022 – 2023

Respected Members,

Pursuant to the M&AOA of Flexible Packaging Association of Converters of Pakistan – (FLEXPAC) Election for the year 2022–2023 is being announced and nominations are hereby invited from interested eligible members of FLEXPAC, desiring to stand for election of Members of Executive Committee.

Election Commission

The Election Commission for holding elections of FLEXPAC shall comprise the following persons. The following Election Commission will manage/organized the Election procedures as required under rule 18 and 19 of the Trade Organization Rules, 2013.

2. Mr. Usman Gul (Election Commission)
3. Mr. Malik Riffat Iqbal (Election Commission)

Seats of Executive Committee:

Elections shall be held to fill the 6 seats for Executive Committee (North & South)

Eligibility to Vote

As per M&AOA of Flexible Packaging Association of Converters of Pakistan and subject to provisions of Section-15 of the Trade Organization Ordinance 2013, the eligibility of a member of FLEXPAC to vote at the election shall be subject to following conditions:

- a) The member has completed two years of valid membership of FLEXPAC as on the date of announcement of election schedule.
- b) The member has fulfilled the conditions of membership and renewal thereof under Rule 11(5) of the Trade Organizations Rules-2013.

Every member eligible to vote shall deposit with the Secretary General, the specimen Membership certificate along with a photograph, and income tax return (company, or concern). The right to vote shall be allowed only to the Proprietor, Partner, or Director of the member firm or company, or a person not below the rank of General Manager authorized by the Board of Directors of a public limited company or a multi-national corporation, as the case may be.

The Proprietor, Partner, or Director of the member firm or company, concern, or a person not below the rank of Director authorized by the Board of Directors of a public limited company or a multi-national company shall be entitled to cast vote at the time of election only if the name of such person has been registered with the Secretary General and his name appears on the list of voters.

Nominations

1. Every member having no outstanding dues (membership fee) in the Association is entitles Nominations to contest the election
2. Nomination paper should be enclosed in a plain and sealed envelope (alongwith all document mentioned in circular).
3. Nomination papers are available with the office of the Association and can be obtained during office hours on the dates mentioned in the schedule.
4. Nomination papers should be drop and courier (out of station candidate) specially at the FLEXPAC's Secretariat, Karachi

Within the period mentioned in the Election Schedule of the issuance of the final voters any person who is eligible to contest the election for the vacant post, shall send his nomination duly proposed, seconded and signed by the candidate to the Secretary General on the prescribed form in accordance with the M&AOA of Flexible Packaging Association of Converters of Pakistan.
